

Family Memoir of the Marcos Years: Ohio, RIS, Southeast Asia

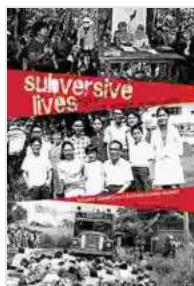

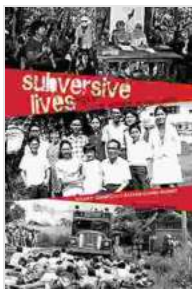
